(57) There is represented preparation method of bionanoceramical superparamagnetics in a device of zeta potential, wherein iron chloride 5% water solution is used as electrolit, and toluol with 0.6-0.7% olein acid additive is placed above thereof. The method provides 0.5 A/dm² density current passing throughout elecyrolit, iron ions extraction from anode, covering therewith rotating cathode surface, wherein ions restoration takes place till forming electroneytral particles, iron particles bringing in toluol layer as a result of cathode rotation, and removal thereby toluol, after which fogging the electrolit process is finished, toluol layer is separated, dried, and the rest is baked in the muffle furnace up to Curie's (769°C) temperature (770-800°C), then, it is oxidized, and alpha iron oxygen of paramagnetic condition is received.
