With the reference 2025/16 of the International Bureau of the World Intellectual Property Organization (WIPO) concerning the international registration N1851853 (ü) registered 27/12/2024 in the name of ÜNLÜ ZİRAAT ALETLERİ ZİRAİ ÜRÜNLERİ SANAYİ VE TİCARET ANONİM ŞİRKETİ, MURADIYE MAH. DEMİRYOLU(OSB) CAD. ÜNLÜ 28, Yunusemre, TR-45120 Manisa, Türkiye, we would like to notify you that the examination made in the Trademark Registry of SAKPATENTI revealed the similar prior trademark:

1. “Ü ÜNLÜ”, with the IR N1155883, registered 09/11/2012 in the name of "ÜNLÜ ZİRAAT ALETLERİ ZİRAİ ÜRÜNLERİ SANAYİ VE TİCARET ANONİM ŞİRKETİ" MURADIYE MAH. DEMİRYOLU CAD. 28, TR-45110 Yunusemre/ Manisa, Türkiye.

Due to the identical names and similar addresses, the examiner presumes that these companies may be one and the same legal entity.

We would like also to inform you that in accordance with the Instruction on Application and registration of trademarks acknowledged on 19.08.2014 by order N05 of the Chairman of LEPL National Intellectual Property Center of Georgia SAKPATENTI, Art. 15(4) – in order to determine the existence of the relative grounds for refusal of registration lay down by Art. 5 of the Trademark Law of Georgia - applied symbol shall be compared with the trademark applications applied at SAKPATENTI and also with the trademarks protected by national or international registration at SAKPATENTI. Accordingly, while providing abovementioned procedure, examination is terminated only with the data fixed in the trademarks register kept by SAKPATENTI.

Also, accordance with the Article 16(4) of the same instruction, If in case of presence of grounds of refusal determined by Subparagraphs “a”-“d”, “f” and “g” Article 5 of the Law, Sakpatenti considers that the applicant or holder of the opposing trademark and/or design is one and the same person or a legally related persons, the applicant shall be sent a written notification about this. If a reply is not submitted within two months from the receipt of the notification, Sakpatenti shall take a relevant decision.

Also, please note that the Article 17 (2) of the Trademark Law of Georgia determines the list of data to be entered into the Register of Trademarks. Particularly, in the case of trademark registration “the Register shall contain a representation of the trademark, the particulars of its holder, the date of its priority, the date of its registration, a list of the goods grouped according to the International Classification for which the trademark is registered and other information regarding the registration.”


In accordance with the Article 19 (1) of the same Law “any amendments to the data whose registration is mandatory under Article 17 (2) of this Law shall be entered in the Register at the request of trademark holder or his representative.”

On the assumption of above-mentioned, the examination of the trademarks, in accordance with the Article 96 (1) of the “General Administrative Code of Georgia” “an administrative body shall be obtained to examine all significant circumstances of the case during the course of the administrative proceedings and to make a decision on the basis of evaluating and comparing the circumstances”, in order to get rid of possible controversy with the prior mark and avoid the provisional refusal of protection on the mark N1851853 (ü), the examination suggests you to make corresponding changes in Trademark Register of SAKPATENTI no later than 2 month from the date of receipt of this notification.

In addition, please be informed that proceedings in Georgia are carried out in the Georgian language.
