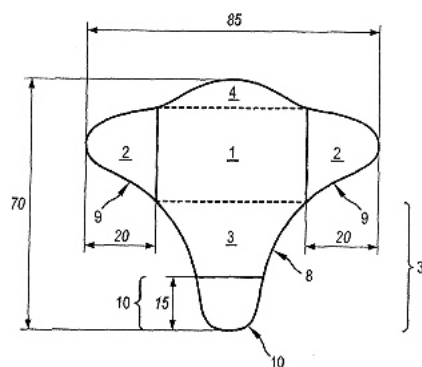

(54) **SUBMARINE RESCUE CHAMBER**

(57) There is represented a rescue chamber comprising cylindrical case with rounded endings, and two hatches 2 fixed parallel along the case in distance from each other. At that, the covers 11 having rack locks are fixed from case internal side, and rack mechanisms are fixed above the covers in the niches executed on submarine flanks between rigid and light cases to fasten submarine adjacent bays mounted on coaming courts from both sides of waterproof partitions. Furthermore, the chamber has two guides 10 equipped with a lock to fix with two metallic stripes furnished in submarine niches low part, metalling 9 to cover niche is welded to chamber low part. At that, two lids 7 are fixed on chamber bulkhead between covers, and a panel 8 is installed between the lids. The panel is equipped with porthole, phone, ventilation fittings to connect high pressure gas hoses, external power supply switch, manometer showing chamber inside pressure. Furthermore, movable case-shaped chambers, and two - light and rigid shields 5 are fixed from bulkhead both sides. The shields are made of, for example, duralumin, composite and other materials in closed condition locking float cushions 6 allocated between them and the case, and made of elastic material, for example, rubber, and connected by pipes with balloons 15 of high pressure air. Also, the platform 13 movable on rollers 20 is mounted on the frames 19 inside of chamber. Folding chairs 17 and high pressure balloons 15 with oxygen, helium and air are executed in the platform. At that, the chamber is equipped with breathing system panel, masks and wiring to conduct treating recompression.

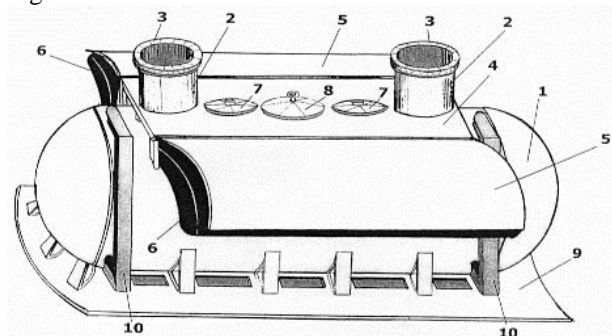
